

# Contract

## 1. Introduction

This commercial contract concerns the agreement concluded with Klawiszedolaptopa.pl Milek Krzysztof. The agreement concerns promotional terms regarding purchases made at Klawiszedolaptopa.pl and **does not oblige to place orders.**

### Definitions:

*The Contractor* - "Klawiszedolaptopa.pl Milek Krzysztof"

*The Contracting Party* - the company signing the contract

*Website (online store)* – www.laptopkey.eu

## 2. Scope of the contract

Klawiszedolaptopa.pl Milek Krzysztof referred to as the *Contractor* undertakes to provide services at the promotional terms referred to in point 4 for the *Contracting Party*. The services shall consist of the sale of goods available on the *Contractor's website*.

## 3. Method of delivery of goods/services

Goods ordered by the *Contracting Party* shall be supplied by mail. The *Contractor* is obliged to dispatch the shipment within 1 business day from the date the payment is registered.

## 4. Price, means of payment, and payment period

The cost of the product, the means of payment, and the payment period are specified on the *Contractor's Website* and constitute the current and widely available: prices, means of payment, and payment period. Additionally, the *Contracting Party* will benefit from the promotional terms, i.e. a **50%** discount on the entire range available in the *online store*. The duration of promotional terms: valid until revoked, but no less than one year from the date of signing the contract.

## 5. Technical documentation

Information on the technical specifications of the products ordered by the *Contracting Party* is available on the *Contractor's Website*.

## 6. The warranty period and conditions

Information about the warranty period and conditions is available on the *Contractor's Website*. These constitute the current in force and widely available warranty period and conditions.

## 7. The rules of arbitration in cases of misunderstandings

In the case of a misunderstanding, the *Contracting Party* will contact the *Contractor* (or the *Contractor* will contact the *Contracting Party*) by telephone, e-mail, or mail to clarify misunderstandings.

## 8. Special terms

Only companies associated with the IT industry may benefit from the promotional terms and sign a contract.

To benefit from the promotional terms, the *Contracting Party* must complete and sign this document and send it to the *Contractor* by e-mail: [support@laptopkey.eu](mailto:support@laptopkey.eu) by 31.01.2018, the terms of the contract shall be available after the *Contracting Party's* registration on the *Contractor's Website* and activation of the discount by the *Contractor* up to 2 days from opening an account by the *Contracting Party*.

## 9. The occurrence of unforeseen circumstances

In the event of unforeseen circumstances, the *Contracting Party* will contact the *Contractor* (or the *Contractor* will contact the *Contracting Party*) by telephone, e-mail, or mail to provide information. The *Contracting Party* and the *Contractor* shall state their positions on each unforeseen circumstance individually.
